Robin,

I would like to request a simple amendment to Assembly Bill 713 (LRB 4335/1), relating to time limits on second degree intentional and reckless homicide.

1. On line 2 of the bill, please delete "940.06"
2. Create language under 939.74 to allow prosecutions under s. 940.06 to commence 15 years after the commission thereof.

Our intent is to alter the bill to allow prosecutions for second degree reckless homicide to be commenced within 15 years of commission of the crime, while second degree intentional homicide will remain as unlimited.

1. Page 2, line 2: delete "940.05, or 940.06" and substitute "or 940.05".

939.74 (2) (am) A prosecution for a violation of s. 940.06 may be commenced

within 15 years after the commission of the violation."
