Rep. Coggs would like two amendments drafted to AB 748, the bill regarding reserve judges.

Specifically, he would like to

#1 "Grandfather" all judges currently eligible as reserve judges

#2 Change the thrust of the bill to allow non re-elected judges to serve as reserve judges, but only in counties outside the district in which they failed to win re-election.

The exec on this bill is Wednesday, Feb. 27th. Spencer would like to have the amendments early next week to submit them to the committee chair 24 hours in advance of the exec.

ASSEMBLY SUBSTITUTE AMENDMENT,
TO 2001 ASSEMBLY BILL 748

1 AN ACT *San. Cat.*; relating to: qualifications of reserve judges.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 SECTION 1. 753.075 (2) (intro.) of the statutes is amended to read:

3 753.075 (2) ELIGIBILITY. (intro.) The Except as provided in sub. (2m) ² the chief
4 justice of the supreme court may appoint any of the following as a reserve judge:

5 SECTION 2. 753.075 (2m) of the statutes is created to read:

6 ^(CS) Ineligibility.
7 753.075 (2m) If a person described in sub. (2) (a) or (b) was defeated at the most
8 recent time that he or she sought election to a circuit court judgeship, the chief justice
9 may not appoint that person as a reserve judge in the circuit in which the person was
10 defeated for the election to a circuit court judgeship.
