and distributors to encourage practitioners to prescribe certain drugs

Analysis by the Legislative Reference Bureau

This bill prohibits any person who manufactures or distributes prescription drugs (manufacturer) in this state from giving, or offering to give, anything of monetary value to any practitioner to encourage the practitioner to issue prescriptions for that manufacturer's drugs. Whe hill defines a practitioner to mean any person who is licensed in this state to prescribe and administer drugs or who is licensed in another state and recognized by this state to prescribe and administer drugs. The prohibition created under the bill does not apply to gifts given or offers made by a manufacturer to a practitioner who is a relative of that manufacturer.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 450.087 of the statutes is created to read:

450.087. Prohibited practices. (1) In this section "relative" has the meaning \checkmark given under s. 13.62 (12g).

(2) (a) Except as provided in par. (b), no manufacturer or distributor may give, or offer to give, anything of monetary value to any practitioner to encourage that


