> I spoke with Mary Klaver and, based on our conversation, I prepared the following language to address the medical school/residency program issue:

>
> 20.9275 (3p) The restriction under subs. (2), (2n) and (3) on the authorization of payment and the payment and use of funds shall apply only to the extent that the application of the restriction does not result in the loss of accreditation from a national accrediting organization of a medical school or medical residency program in this state.

> Mary, is "national accrediting organization" a fairly commonly understood term? You may want to verify that with Kathy Kuhn.
