3 2. Page 58, line 10: delete "(1)" and substitute "(1)".

4 3. Page 58, line 11: delete "(9)." and substitute "(9); and".

5 4. Page 58, line 12: before that line insert:

6 "SECTION 103g. 11.50 (2) (b) 6. of the statutes is created to read:

8 SECTION 103r. 11.50 (2) (c) of the statutes is amended to read:

17 disbursement level specified under s. 11.31 (1), as adjusted under s. 11.31 (9), for the
18 office that the candidate seeks, but without respect to any adjustment under s. 11.31
19 (3n) or (3r)."

20 **6.** Page 64, line 12: delete the material beginning with ", at" and ending with
21 "(cm)," on line 12.

22 **7.** Page 64 line 14: delete "that exceeds 50%" and substitute "as reported
23 under sub (2) (c), that is equal to at least 50% but is less than 100%".
