1 At the locations indicated, amend the bill as follows:

2 1. Page 74, line 16: after that line insert:

3 "SECTION 142e. 71.10 (3) (d) of the statutes is created to read:

4 71.10 (3) (d) If an individual's income tax return is prepared by an income tax
5 preparer who files the return electronically and if the individual does not indicate
6 that he or she does not want to make a designation under par. (a), the income tax
7 preparer shall designate \$5 for transfer to the Wisconsin election campaign fund
8 under s. 11.50 or, if the individual is married and files a joint return, the preparer
9 shall designate \$5 for each individual. Designations made under this paragraph
10 shall be placed in the general account."

11 2. Page 76, line 7: delete "and (b)" and substitute "(b), and (d)".
