2 ✓ 1. Page 7, line 21: after that line insert:

3 (3) "SECTION (11D.) 50.36 (3d) of the statutes is created to read:

4 50.36 (3d) (a) A hospital shall develop and maintain a system under which the  
5 hospital may grant emergency staff privileges to a health care provider, as defined  
6 in s. 146.81 (1), to whom all of the following *apply* apply:

7 1. The health care provider seeks to provide care at the hospital during a period  
8 of a state of emergency related to public health declared by the governor under s.  
9 166.03 (1) (b) 1. ✓

10 2. The health care provider does not have staff privileges at the hospital at the  
11 time *that* the state of emergency related to public health is declared by the governor under  
12 s. 166.03 (1) (b) 1.
