1 At the locations indicated, amend the bill as follows:

2 1. Page 1, line 4: before that line insert:

3 "SECTION 1e. 59.10 (1) (c) of the statutes is amended to read:

4 59.10 (1) (c) *Compensation*. The method of compensation for supervisors shall
5 be determined by the board except that, in a county with a population of at least
6 500,000, the board may not increase the annual salary of a supervisor for any term
7 of office other than the next succeeding term of office, or provide an annual salary
8 that increases during a supervisor's term of office."

9 2. Page 1, line 4: delete "SECTION 1" and substitute "SECTION 1m".
