

The method of compensation for supervisors shall 5 be determined by the board except that, in a county with a population of at least 500,000, the board may not increase the annual salary of a supervisor for any term 6 of office other than the next succeeding term of office, or provide an annual salary
- that increases during a supervisor's term of office.". 9
