"3. Referendum." The board may adopt a resolution calling for a referendum, to be held at the next succeeding spring primary or election or September primary

or general election to be held not earlier than 42 days after the adoption of the

resolution, on whether the board may reduce its size under subd. 1. The referendum question shall be substantially as follows: "May the board of supervisors of
