3 insurance to develop uniform health insurance application forms ~~and uniform~~
4 ~~medical claim processing forms~~,".

5 2. Page 10, line 24: after that line insert:
6 "SECTION 12m. 146.96 of the statutes is created to read:
7 146.96 Uniform claim processing form. Beginning no later than July 1,
8 2004, every health care provider, as defined in s. 146.81 (1), shall use the uniform
9 claim processing form developed by the commissioner of insurance under s. 601.41
10 (8) (c) when submitting a claim to an insurer."

12 "SECTION 17m. 601.41 (8) of the statutes is created to read:

10 employer applies for coverage under a group health benefit plan offered by the small
11 employer insurer.) ✓

12 (c) If the federal government has not developed, by July 1, 2003, a uniform
13 claims processing form that must be used by all health care providers for submitting
14 claims to insurers and by all insurers for processing claims ~~made~~ ^{submitted} by health care
15 providers, the commissioner shall develop, by no later than December 31, 2003, a
16 uniform claims processing form for that purpose.

17 SECTION 17p. 610.65 of the statutes is created to read:
18 610.65 Uniform claim processing form. Beginning no later than July 1,
19 2004, every insurer shall use the uniform claim processing form developed by the
20 commissioner under s. 601.41 (8) (c) when processing a claim submitted by a health
21 care provider, as defined in s. 146.81 (1)."

23 "SECTION 19m. 635.10 of the statutes is created to read:

1 **635.10 Uniform application.** Beginning no later than the first day of the
2 13th month beginning after the effective date of this section [revisor inserts date],
3 every small employer insurer shall use the uniform application form developed by
4 the commissioner under s. 601.41 (8) (b) ✓ when a small employer applies for coverage
5 under a group health benefit plan offered by the small employer insurer.”
