#### Analysis by the Legislative Reference Bureau

This bill is a reconciliation bill under Joint Rule 81m (2) (b). In regard to the recording and filing of documents with the office of register of deeds, the bill reconciles three acts that cannot be reconciled by the revisor of statutes in preparing the statutes.
