1 **Relating to:** the life and public service of LeRoy Pete Litscher.

2 Whereas, LeRoy Pete Litscher was born on January 15, 1922, in the Town of
3 Troy, Sauk County, Wisconsin, and died on October 15, 2000, at St. Clare Hospital,
4 Baraboo, Wisconsin, at the age of 78; and

5 Whereas, he graduated from Prairie du Sac high school in 1940; and

6 Whereas, he was an enthusiastic farmer, and was dedicated to public service;

7 and

8 Whereas, *Mr. Litscher* he served on the local board of directors of the Farmer's Union Co-op
9 (now Cenex) for 26 years, the Wisconsin Farmers Union state board for many years,
10 the board of the Baraboo Milk Producers, and the board of the Wisconsin Association
11 of Drainage Districts; and

12 Whereas, he served on the Lower Narrows School Board, the Baraboo School
13 Board, and the Sauk County Board for many years; and

1 Whereas, he was appointed by Governor Patrick Lucey to serve on the Cable
2 Television Study Commission in 1971; and

3 Whereas, he was elected to the Wisconsin Assembly in a November 1975 special
4 election and reelected in 1976; and

5 Whereas, ~~he~~ ^{Mr. Litscher} served as vice chairperson of the ~~Assembly~~ [✓] Committees ~~on~~
6 ~~Revenue and Natural Resources~~, as a member of the ~~Assembly~~ [✓] Committee on
7 ~~Agriculture~~, and on the Legislative Council's ~~Natural Resources~~ Committee and its
8 ~~Subcommittee on Floodplains~~; and

9 Whereas, he felt an abiding responsibility to leave the land in better condition
10 than he found it and had a hard time believing that anyone was all bad, as expressed
11 in this greeting: ^{AA} "There is a destiny that makes us brothers. ^{AA} None goes his way alone.

12 All that we send into the lives of others, [✓] comes back into our own."; now, therefore,
13 be it

14 **Resolved by the assembly, the senate concurring, That** the Wisconsin
15 Legislature does hereby commend the life and exemplary public service of LeRoy
16 Pete Litscher, and extends its sympathies to his wife, his children and their families,
17 and his brothers and sisters and their families; and, be it further

18 **Resolved, That** the assembly chief clerk shall provide copies of this joint
19 resolution to Mr. Litscher's wife, [✓] Joan, his daughter, [✓] Laurie Seifert (Hartland), and
20 his son, [✓] Patrick Litscher (Madison).
