Analysis by the Legislative Reference Bureau

Joint Rule 3 (5): This joint resolution provides that if a conference committee, or a successor conference committee, has not submitted a report within 30 days after the appointment of the committee another conference committee consisting of members who have not served on the conference committee, or a successor conference committee, must be appointed within 5 days and may proceed to further consideration of the proposal.

~~Resolved by the assembly, the senate concurring, That:~~

SECTION 1. Joint rule 3 (5) is created to read:

JOINT RULE 3 (5) If the committee of conference, or a successor committee of conference, has not submitted a report within 30 days after the appointment of the committee, the committee of conference is dissolved. If so dissolved, another committee of conference consisting of members who have not served on the committee of conference or a successor committee of conference shall be appointed within 5 days as provided under the rules of the senate and assembly for the initial

1 appointments and may proceed to further consideration of the proposal or of
2 amendments thereto. //
