Joint Analysis by the Legislative Reference Bureau
Assembly Rule 8: This rule is created to address fund-raising social events in
Dane County during floorperiods and special and extraordinary sessions.

3 **Resolved by the assembly, the senate concurring, That:**

4 **SECTION 1. Joint rule ~~RULE NUMBER~~ is created to read:**

5 *CS* *Joint* **Assembly Rule 8. Campaign committee activity.** (1) A member may not
6 schedule, hold, attend, or contribute money for or at; or authorize a legislative
7 campaign committee, as defined in section 11.01 of the statutes, to schedule, hold,
8 attend, or contribute money for or at; and a member may not schedule, hold, attend,
9 or contribute money for or at; or authorize the member's personal campaign
10 committee, as defined in section 11.01 of the statutes, to schedule, hold, attend, or
11 contribute money for or at; a fund-raising social event in Dane County during a
12 floorperiod of the legislature or during a special or extraordinary session.

1 (2) Subsection (1) does not apply to a fund-raising social event of a legislative
2 campaign committee held during the period between the first day authorized for
3 filing nomination papers for any special election to the ~~assembly~~ ^{Senate or} and the date of the
4 special election.

5 (3) Subsection (1) does not apply to a fund-raising social event of a current
6 member of the ~~assembly~~ ^{Senate or} or his or her personal campaign committee held during the
7 period between the first day authorized for filing nomination papers for any office for
8 which a current member of the ~~assembly~~ ^{Senate or} is a candidate and the date of the election
9 for that office, if the event is held within the boundaries of the jurisdiction or district
10 served by the office for which the current member of the ~~assembly~~ ^{Senate or} is a candidate.

11 (4) Subsection (1) does not apply to a fund-raising social event of a current
12 member of the ~~assembly~~ ^{Senate or} or his or her personal campaign committee held during the
13 period between the first day authorized for filing nomination papers for any office,
14 other than representative to the assembly, for which a current member of the
15 assembly is a candidate and the date of the election for that other office.
