5 Whereas, ^{Joe Looby} ~~Joe~~ married Mert Brettingen Madsen on July 12, 1944, in Manitowish, ^{Wisconsin}

7 Whereas, during World War II, ^{Joe} ~~Mr.~~ Looby served in the U.S. Army from 1943

4 Whereas, during his tenure in the assembly, ^{Joe} ~~Mr.~~ Looby served on several
 5 standing committees including the Committee on Labor (chairperson for 12 years),
 6 Committee on Municipalities, and Committee on Veterans and Military Affairs; now,
 7 therefore, be it

8 **Resolved by the assembly, the senate concurring, That** the members of the
 9 Wisconsin legislature commend the devoted public service that Joseph L. Looby
 10 contributed to this state and his community, express ^g ~~their~~ sorrow at his death, and
 11 extend ^g ~~their~~ condolences to his family and friends; and be it further
