


In response to AJR 35, Planned Parenthood of Wisconsin has noted some areas where the resolution could be improved to highlight some significant inequities not addressed in the current proposal. While we applaud the sponsors for drawing attention to this issue, we feel the addition of amendments to address existing reproductive related inequities would be important to acknowledge to encourage their inclusion in any subsequent policy initiatives.

When this issue came up for debate on the Assembly Floor, the bill's author, Representative Bonnie Ladwig, told us and Representative Wasserman that she did not want any amendments to the Resolution because it was modeled after a national resolution. In comparing AJR 35 to the sample resolution by

the Woman's Health Care Platform it was modeled after, however, we have noted that AJR 35 is not identical. Specifically, on page four, lines 17-18 of AJR 35, language has been added to include references to abortion that are not contained in the national model.

Both Representatives Wasserman and Berceau were prepared to offer amendments to AJR 35 on the Assembly Floor, but Assembly Leadership acted too quickly for them to present their amendments. We would appreciate your consideration of the following amendments in preparation of future action in the Senate:

- Whereas, women make only 72 cents to every dollar a man makes and pay 68% more in out of pocket costs for their health care; and
- Whereas 97% of large group insurance plans cover most prescriptions, but only 1/3 of them cover all five FDA approved contraceptives for women; and
- Whereas, women are biologically more susceptible to sexually transmitted infections and are more likely to bear the negative long term consequences including involuntary sterilization and death; and
- Whereas, women are 10 - 20 times more likely to contract HIV and HIV is the second leading cause of death in African Americans and the third leading cause of death in Latinas; and
