

## 2001 ASSEMBLY JOINT RESOLUTION

1 **Relating to:** the life and public service of John Quentin Radcliffe.

2           Whereas, John Quentin Radcliffe was born on May 19, 1920, in Little Falls,  
3 Wisconsin, and died on August 19, 2001, in Osseo, Wisconsin; and

4           Whereas, he was educated at Black River Falls elementary<sup>school</sup> and Tony High  
5 School; and

6           Whereas, John married Ione Gunderson on June 29, 1940, in Black River Falls,  
7 Wisconsin; and

8           Whereas, during World War II, Mr. Radcliffe served in the U.S. Navy aboard a  
9 PT boat in Espirtu Santos, New Hebrides; and

10           Whereas, after his military service, Mr. Radcliffe was employed by the Gillette  
11 tire company, retiring from the Uniroyal tire company after 24 years of service; and

12           Whereas, John served on the Eleva-Strum school board; and

13           Whereas, he was elected to the Wisconsin assembly representing Jackson and  
14 Trempealeau counties in 1964 and served continuously from the 1965 through 1971  
15 sessions; and
