2001 ASSEMBLY JOINT RESOLUTION

2-30 pm

1 **Relating to:** congratulating and commending the University of Wisconsin men's
2 basketball team on its 2001-2002 Big Ten Conference Championship.

3 Whereas, this season was supposed to be the "down" year with a new head
4 coach, inexperienced players, and a tough schedule; and

5 Whereas, to the contrary, it has been an astonishing season, considering that
6 the players had to adjust to a new system under Head Coach Bo Ryan, were
7 handicapped by the loss of 3 players even before their first game, and relied on a
8 ~~seven~~ ⁷ man rotation consisting of 2 seniors, one junior, 2 sophomores, and 2 freshmen;
9 and

10 Whereas, with an 11.5 ^{Δ to Δ} conference record, the team won its first Big Ten
11 Conference championship since 1947, a 55^v-year wait; and

12 Whereas, with 18 wins overall, Coach Ryan is the winningest first-year coach
13 in ~~UW~~ ^{UW} men's basketball history; and

1 Whereas, the 2001-2002 men's basketball team is the first ~~UW~~ team since the
2 1941 ~~UW~~ men's basketball National Championship squad to defeat all conference
3 opponents during one season; and

4 Whereas, the basketball team is the first Big Ten team since 1987-88 to win at
5 Indiana, Michigan State, and Minnesota in the same season; and

6 Whereas, in winning games at Michigan State and Indiana, they ended
7 Michigan State's 53-game home winning streak and Indiana's 22-game winning
8 streak over ~~UW~~ teams at Assembly Hall that spanned over 25 years; and

9 Whereas, the 2001-2002 team is the number one seed in the Big Ten Men's
10 Basketball Conference Tournament commencing on March 7 in Indianapolis, a
11 ranking no other ~~UW~~ men's basketball team has accomplished; and

12 Whereas, the University of Wisconsin men's basketball team has proven that
13 hard work and determination by student athletes is the road map to success; and

14 Whereas, it is now time to savor Badger magic and say or shout "Go Badgers"
15 with pride; now, therefore, be it

16 **Resolved by the assembly, the senate concurring, That** the members of the
17 legislature of the state of Wisconsin commend and congratulate the 2001-2002
18 University of Wisconsin men's basketball team for its hard work and dedication in
19 advancing men's basketball to one of its highest levels, and share the pride of the
20 citizens of the state of Wisconsin in their team achievement; and, be it further

21 **Resolved, That** the assembly chief clerk shall provide copies of this joint
22 resolution to Head Coach Bo Ryan, his staff, each member of the team, and Athletic
23 Director Pat Richter.
