1 **To create** assembly rule 98; **relating to:** prohibiting campaign contributions
 2 between January 1 of each odd-numbered year and June 1 of the next
 3 even-numbered year.

Analysis by the Legislative Reference Bureau

Assembly Rule 98: This rule is created to prohibit campaign contributions between January 1 of each odd-numbered year and June 1 of the next even-numbered year.

Resolved by the assembly, That:

5 SECTION A. Assembly rule 98 is created to read:

6 **ASSEMBLY RULE 98. Campaign contributions.** (1) In this rule, "contribution,"
 7 "legislative campaign committee," and "personal campaign committee" have the
 8 meanings given for the terms in section 11.01 of the statutes.

9 (2) A legislative leader may not schedule, hold, or attend, or solicit, make, or
 10 receive a contribution for or at; or authorize a legislative campaign committee to
 11 schedule, hold, or attend, or solicit, make, or receive a contribution for or at; and a

1 member may not schedule, hold, or attend, or solicit, make, or receive a contribution
2 for or at; or authorize the member's personal campaign committee to schedule, hold,
3 or attend, or solicit, make, or receive a contribution for or at; a fund-raising social
4 event or otherwise between January 1 of each odd-numbered year and June 1 of the
5 next even-numbered year.

6 (3) Subsection (2) does not apply to a fund-raising social event of a legislative
7 campaign committee held during the period between the first day authorized for
8 filing nomination papers for any special election to the assembly and the date of the
9 special election.

10 (4) Subsection (2) does not apply to a fund-raising social event of a current
11 member of the assembly or his or her personal campaign committee held during the
12 period between the first day authorized for filing nomination papers for any office for
13 which a current member of the assembly is a candidate and the date of the election
14 for that office, if the event is held within the boundaries of the jurisdiction or district
15 served by the office for which the current member of the assembly is a candidate.

16 (5) Subsection (2) does not apply to a fund-raising social event of a current
17 member of the assembly or his or her personal campaign committee held during the
18 period between the first day authorized for filing nomination papers for any office,
19 other than representative to the assembly, for which a current member of the
20 assembly is a candidate and the date of the election for that other office. ✓ ⊙
