4 **SECTION 1.** Assembly rule 7 (4) is amended to read:

5 ~~Assembly Rule 7 (4)~~ The committee on assembly organization shall determine
6 the number of assembly ~~employes~~ employees assigned to each member and the type
7 of duties and responsibilities assigned to each ~~employe~~ employee, but may not assign
8 the duty or responsibility of press spokesperson to any employee. A member may not
9 assign the duty or responsibility of press spokesperson to any employee.
