“(5) A member may not solicit any contribution, as defined in section 11.01 of the statutes, or solicit another person to solicit a contribution, for a registrant under chapter 11 of the statutes ~~and~~ a member may not solicit any donation or request another person to solicit a donation to be used for the purpose of issue advocacy, during a floor period of the legislature or during a special or extraordinary session.

(6) Subsection (5) does not apply to a contribution or donation solicited on behalf of a candidate for any office at a regular or special election, or that person's personal campaign committee, during the period between the first day authorized for filing nomination papers for that election and the date of that election.

(7) Subsection (5) does not apply to a contribution or donation solicited on behalf of a legislative campaign committee during the period between the first day authorized for filing nomination papers for any special election to the senate or assembly and the date of that special election.

(9) In this rule, “issue advocacy” means making a communication by means of one or more communications media, as defined in section 11.01 of the statutes, or a mailing of 50 or more pieces of substantially identical material, or through a telephone bank operator, other than a communication that is exempt from reporting under section 11.29 of the statutes, during the period between the 60th day preceding an election and ending on the date of that election and that includes the name or likeness of a candidate whose name is certified to appear on the ballot at that

election, the name of an office to be filled at that election, or the name of a political party.”
