5 any matter to the assembly shall rise in his or her assigned place and respectfully  
6 address the presiding officer. Upon being recognized, the member shall confine his  
7 or her remarks to the question before the assembly and shall avoid personalities. A  
8 member may be recognized or addressed only by ~~reference to the member's county~~  
9 ~~or municipality of residence, by the main county or municipality in that member's~~  
10 ~~district~~ ~~or by the~~ the number of the member's district."
