## 2001 ASSEMBLY RESOLUTION

1 **To create** assembly rule 98m; **relating to:** preparation of additional local fiscal  
2 estimates by the legislative fiscal bureau.

---

### *Analysis by the Legislative Reference Bureau*

*Assembly Rule 98m:* The rule is created to require the legislative fiscal bureau, independently of the preparation of any other local fiscal estimate by a state agency, to prepare an original local fiscal estimate on any bill requiring a local fiscal estimate. The legislative fiscal bureau is directed to consult with local governmental officials and employees in preparing the local fiscal estimate. Bills requiring local fiscal estimates under this rule may not be considered by the assembly, and may receive neither a public hearing nor be considered by an assembly standing committee, before the receipt of the local fiscal estimate prepared under this rule.

3 **Resolved by the assembly, That:**

4 **SECTION 1.** Assembly rule 98m is created to read:

5 **ASSEMBLY RULE 98m. Additional local fiscal estimates.** (1) The legislative  
6 fiscal bureau, independently of the preparation of any other local fiscal estimate by  
7 a state agency, shall prepare an additional original local fiscal estimate on any bill  
8 requiring a local fiscal estimate.

1 (2) The legislative fiscal bureau shall consult with local governmental officials  
2 and employees in preparing the local fiscal estimate under sub. (2).

3 (3) An original fiscal estimate prepared under sub. (1) shall be submitted to the  
4 legislative reference bureau for review by the requester under joint rule 48 and for  
5 reproduction and insertion in the bill jacket envelope.

6 (4) Bills requiring local fiscal estimates under this rule may not be considered  
7 by the assembly, and may receive neither a public hearing nor be considered by an  
8 assembly standing committee, before the receipt of the local fiscal estimate prepared  
9 under this rule.

10 (5) Any member may, at any time that a bill is before the assembly, raise the  
11 issue that the bill requires a local fiscal estimate prepared under this rule, and if the  
12 presiding officer determines that the bill, not having the estimate, requires an  
13 estimate, the presiding officer shall direct the legislative fiscal bureau to prepare the  
14 requisite estimate.

15 (6) Local fiscal estimates prepared under this rule are required on original bills  
16 only and not on substitute amendments or amendments.
