4 <sup>(CS)</sup> **Section 1. Limit on redistricting expenditures.**

5 (1) LEGISLATIVE FISCAL BUREAU REPORT. (a) The legislative fiscal bureau shall  
6 determine the amount spent by the assembly in 1990, 1991, and 1992 for contracted  
7 services, other than for those performed by employees of the Wisconsin legislature  
8 in the performance of their regular job responsibilities, to assist the assembly, its  
9 committees, and its members in the redistricting of congressional and legislative  
10 districts.
