## 2001 ASSEMBLY RESOLUTION

1 **Relating to:** the life, military service, and sacrifice of Marc Ian Nieto, ~~son~~ of Fond  
2 du Lac, Wisconsin.

3 Whereas, Marc Ian Nieto is the son of Mrs. Sharon Priepeke, of the State of  
4 Wisconsin, and graduated from Goodrich High School, Fond du Lac, Wisconsin, in  
5 1994; and

6 Whereas, Marc Nieto joined the United States Navy as a Seaman Recruit, was  
7 promoted ~~twice~~<sup>5</sup> times, and ultimately earned the title of Petty Officer 2nd Class,  
8 Engineman, serving on the USS Cole (DDG 67); and

9 Whereas, Marc Nieto served honorably as a <sup>U.S.</sup> Navy sailor aboard the USS Cole  
10 (DDG 67), and was ~~two~~<sup>2</sup> weeks short of finishing his ~~six~~<sup>six</sup>-year Navy tour of duty, when  
11 suicidal terrorists attacked and bombed out the side of the USS Cole, <sup>on</sup> October 12,  
12 2000, in Yemen; and

13 Whereas, Marc Nieto will be remembered not only for his outstanding military  
14 service, but <sup>also</sup> for his concern for others, his integrity, his sense of humor, and his  
15 generosity to friends and family; now, therefore, be it
