Relating to: A RESOLUTION, Requesting the United States Congress not to attempt to repeal or rescind any of the tax relief legislation passed by the United States Congress in May 2001.

WHEREAS, the Economic Growth and Tax Relief Reconciliation Act of 2001 (H.R. 1836) was passed with bipartisan support; and

WHEREAS, the bill granted much-needed tax relief for all working families in ~~State~~ Wisconsin; and

WHEREAS, some members of the United States Congress are calling for the repeal or delay of parts of the tax relief bill, which would, in effect, raise taxes on ~~State's~~ families; *now, therefore, be it*

~~NOW, THEREFORE, BE IT RESOLVED~~, by the ~~House/Senate~~ *Members* of the ~~State of Wisconsin~~ *Assembly*, that the Congress of the United States be respectfully requested to leave the tax cuts in the Economic Growth and Tax Relief Reconciliation Act of 2001 (H.R. 1836) intact, to allow the implementation or acceleration of the tax relief therein, and to add further tax relief measures if needed; *and, be it further*
