3 tractor or implement of husbandry,".

4 ✓ 2. Page 6, line 29: after that line insert:

5 "SECTION 14c. 167.31 (1) (bg) of the statutes is created to read:

6 167.31 (1) (bg) "Family member of the landowner" means a person who is
7 related to the landowner as a parent, child, spouse, or sibling.

8 SECTION 14f. 167.31 (1) (bn) of the statutes is created to read:

9 167.31 (1) (bn) "Farm tractor" has the meaning given in s. 340.01 (16).

10 SECTION 14j. 167.31 (1) (dm) of the statutes is created to read:

11 167.31 (1) (dm) "Implement of husbandry" has the meaning given in s. 340.01

or an employee of the landowner
of the landowner who is using a firearm, bow, or crossbow to shoot wild animals from
a farm tractor or an implement of husbandry on the landowner's land that is located
in an area designated by the department of natural resources as a chronic wasting
disease eradication zone.".
