**ASSEMBLY AMENDMENT,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO ASSEMBLY BILL 1**

within 14 working days after the date of the department's submittal

in an amount exceeding \$3,000,000 ↗

At the locations indicated, amend the substitute amendment as follows:

1. Page 3, line 3: after "cervids" insert "If the department receives federal funds for the purpose of managing, or conducting testing for, chronic wasting disease, the department shall submit a plan to the joint committee on finance specifying the manner in which the department proposes to expend the funds. If the cochairpersons of the committee do not notify the department that the committee has scheduled a meeting for the purpose of reviewing the plan, the plan may be implemented as proposed by the department. If, within 14 working days after the date of the department's submittal, the cochairpersons of the committee notify the department that the committee has scheduled a meeting for the purpose of reviewing the proposed plan, the plan may be implemented only upon approval of the committee."
