**ASSEMBLY AMENDMENT ,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO ASSEMBLY BILL 1**

1 At the locations indicated, amend the substitute amendment as follows:

- 2 1. Page 3, line 3: after "cervids" insert "If the department receives federal
3 funds for the purpose of managing, or conducting testing for, chronic wasting disease,
4 the department shall submit a plan to the joint committee on finance specifying the
5 manner in which the department proposes to expend the funds. If the cochairpersons
6 of the committee do not notify the department that the committee has scheduled a
7 meeting for the purpose of reviewing the plan, the plan may be implemented as
8 proposed by the department. If, within 14 working days after the date of the
9 department's submittal, the cochairpersons of the committee notify the department
10 that the committee has scheduled a meeting for the purpose of reviewing the
11 proposed plan, the plan may be implemented only upon approval of the committee."
