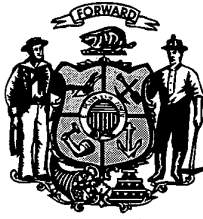

Current Language

Current language at s. 21.26 states that the Department of Military Affairs shall administer the Youth Challenge program for disadvantaged youth under 32 USC 509.

Proposed Change

Remove this language along with \$1,290,400 in GPR funding in s. 20.465(4)(c) and \$1,912,600 in federal funding in s. 20.465(4)(m).

Effect of the Change

The department will no longer be required to operate the Youth Challenge Program beginning in FY03 and no funding will be part of the department's base funding for the next biennium.

All of these positions are in DMA and both the GPR appropriation and the FED appropriation s.20.465 (4)(m) should be eliminated. Bob, the GPR reduction will be drafted in the central GPR draft that includes the percentage cuts for many state agencies. The draft for Youth Challenge should eliminate the GPR alpha appropriation, 20.465(4)(c), but not include a reduction in funding. The federal funding for Youth Challenge does not need to be eliminated after all. If the elimination of the program happens, the next budget bill will eliminate that appropriation.
