The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 (1) FINANCIAL SERVICES. In the schedule under section 20.005 (3) of the statutes
4 for the appropriation to various state agencies under section 20.865 (1) (em) of the
5 statutes, as affected by the acts of 2001, the dollar amount is decreased by \$6,000 for
6 fiscal year 2001-02 and the dollar amount is decreased by \$22,600 for fiscal year
7 2002-03 to reduce spending for the purpose for which the appropriation is made.

1 (2) PRIVATE FACILITY RENTAL INCREASES. In the schedule under section 20.005 (3)
2 of the statutes for the appropriation to various state agencies under section 20.865
3 (2) (a) of the statutes, as affected by the acts of 2001, the dollar amount is decreased
