Motion:

Move to transfer \$1,500,000 in 2001-02 and \$3,300,300 in 2002-03 from WHEDA's unencumbered general reserve fund to the Department of Administration for housing grants and loans on a one-time basis.

Delete \$1,500,000 GPR in 2001-02 and \$3,300,300 GPR in 2002-03 under the DOA's housing assistance function for housing cost grants and loans to low- and moderate-income families. Create a new PR-funded biennial appropriation under DOA to accept the WHEDA funds, and authorize the payment of housing cost grants and loans from this new appropriation account and provide expenditure authority of \$1,500,000 PR in 2001-02 and \$3,300,300 PR in 2002-03. Sunset the PR appropriation on June 30, 2003. → July 1, 2003
