Please draft a session law provision for DOA to effect motion #199. This is a separate and additional reduction to DOA from the additional reduction imposed under motion #174.

For the dollar amounts identified in motion #199, the reductions should be applied to the agency's s. 20.505(1)(a) appropriation.
