Sale of Land by DNR

Motion:

Move to prohibit DNR from entering into a contract to sell or exchange state-owned land valued in excess of \$75,000 without first notifying the Joint Committee on Finance of the proposed transaction. Specify that if the Committee wishes to review the sale or exchange, the Committee must notify DNR within 14 working days of receiving the notice that it has scheduled a meeting to review the proposal. The Department may then make the sale or exchange only with the approval of the Committee. To approve the Committee must determine that the amount or the value of the land received by DNR under the transaction adequately reimburses the state.

9           department land <sup>that has a fair market value in excess of \$75,000</sup> unless <sup>the department</sup> first notifies the joint committee on finance in writing of  
10          the proposed contract. If the cochairpersons of the committee do not notify the  
11          department within 14 working days after the date of the department's notification  
12          that the committee has scheduled a meeting to review the proposed contract, the  
13          department may enter into the contract. If, within 14 working days after <sup>receiving from</sup> ~~the~~ notification <sup>by</sup> the department, the cochairpersons of the committee notify the  
14          department that the committee has scheduled a meeting to review the proposed  
15          contract, the department may enter into the contract only on the approval of the  
16          committee.

18          department land only if the committee determines that the level of reimbursement

9 (2) The department may not enter into a contract to sell or exchange  
10 department land that has a fair market value in excess of \$75,000 unless the  
11 department first notifies the joint committee on finance in writing of the proposed

1 contract. If the cochairpersons of the committee do not notify the department within  
2 14 working days after the date of the department's notification that the committee  
3 has scheduled a meeting to review the proposed contract, the department may enter  
4 into the contract. If, within 14 working days after receiving the notification from the  
5 department, the cochairpersons of the committee notify the department that the  
6 committee has scheduled a meeting to review the proposed contract, the department  
7 may enter into the contract only on the approval of the committee.

8 (3) The joint committee on finance may approve a contract under sub. (2) to sell  
9 department land only if the committee determines that the level of reimbursement  
10 to be received by the state adequately reimburses the state for its cost in acquiring  
11 and developing the department land. The joint committee on finance may approve  
12 a contract under sub. (2) to exchange department land for other land only if the  
13 committee determines that the value of the land to be received by the state in the  
14 exchange adequately reflects the state's cost in acquiring and developing the  
15 department land.

16 (4) The approval process under subs. (2) and (3) is in addition to any approval  
17 process that may apply to the sale or exchange of the department land under s. 13.48  
18 (14) (d).".
