4 19.42 (13) (c) All positions identified under s. 20.923 (2), (4), (4g), (6) (f) to (h),
5 (7), and (8) to (10), except clerical positions."

6 2. Page 50, line 25: after that line insert:

7 "SECTION 71t. 20.923 (16) of the statutes is amended to read:

8 20.923 (16) OVERTIME AND COMPENSATORY TIME EXCLUSION. The salary paid to
9 any person whose position is included under subs. (2), (4), (4g), (5), (7), and (8) to (12)
10 is deemed to compensate that person for all work hours. No overtime compensation
11 may be paid, and no compensatory time under s. 103.025 may be provided, to any
12 such person for hours worked in any workweek in excess of the standard basis of
13 employment as specified in s. 230.35 (5) (a)."
