Note:

This motion would modify the Governor's recommendation to limit the UW Board of Regents from increasing undergraduate resident tuition by more than 8% in 2002-03. The Governor's proposal would restrict the Board from increasing tuition for resident undergraduate students in 2002-03 by an amount that exceeds 10% of the tuition charged to resident undergraduate students in the 2001-02 academic year unless the Board obtains the approval of the Joint Committee on Finance under s.13.10 of the statutes and the approval of the DOA Secretary. The Governor's proposal permits the Board to increase tuition beyond the 10% limit for differential tuition initiatives in 2002-03 that are approved by the Board, and that are not already included in the tuition appropriation schedule as long as such increases are not used to offset proposed GPR funding reductions for the UW System.
