Authority to Charge Fees

Motion:

Move to authorize the Society to charge fees for services, in addition to those specifically authorized under Chapter 44 of the statutes governing the Historical Society, except for cases in which the statutes specifically prohibit the Society from charging fees for certain activities.

---

Note:

Under current law, Chapter 44 of the statutes authorizes the Historical Society to charge fees for a number of its services, including: (1) admission to historic sites and other buildings operated by the Society, including the Historical Society museum and other educational facilities, and exhibits, lectures or other events; (2) fees for use of the main library; (3) sales of postcards, souvenirs and other merchandise to defray operational costs; (4) fees relating to certification of expenditures under the state historic rehabilitation credit program; and (5) fees for school services (publications, seminars for teachers and other materials). The Society is specifically prohibited from charging fees to any faculty, academic staff or student of the University of Wisconsin System for use of the main library.

This motion would allow the Society to charge fees for any other services and/or materials that it provides, other than those specifically prohibited by statute.
