Working Group Recommendation: Request the Joint Legislative Audit Committee to direct the Legislative Audit Bureau to review DNR land acquisition practices under the Warren Knowles-Gaylord Nelson Stewardship 2000 Program. LAB would consider the following issues:

- (a) The purchase price paid by DNR for property compared to prices paid for comparable property in a given geographical area;
- (b) The annual aids in lieu of property taxes payment paid by the state for lands purchased by DNR compared to property tax payments previously received by local government; and
- (c) The difference between the appraised and the assessed value of land acquired by DNR.
