

### Allocation of \$2 Million of Student Financial Aid Funding

Modify the Joint Finance Committee version of the budget to reallocate the \$2 million GPR of funding provided to WHEG-UW and WHEG-TCS, in order to provide the same percentage increase of funding to the tuition grant, WHEG-UW and WHEG-TCS programs. This would provide \$778,100 to the TG program, \$726,500 to the WHEG-UW program and \$495,400 to the WHEG-TCS program in 2002-03, which would represent a 3.52% increase in funding for each program, compared to the funding levels provided in Act 16 for 2002-03.
