**TO ASSEMBLY BILL 1**

3. Modify the Joint Committee on Finance budget by restoring \$ 45,800 FED in 2002-03 and 1.0 FED position to the Department of Health and Family Services and by restoring \$61,500 FED in 2002-03 and 1.0 FED position to the Department of Workforce Development. These are federally-funded positions that are located in the Department of Administration's federal-state relations office in Washington, D.C.

3 "SECTION 14m. 16.003 (2) of the statutes is amended to read:

6 performing the duties of the department. All staff shall be appointed under the
