WORKING GROUP

Stewardship Bonding

Reduce the bonding authorization under the Warren Knowles-Gaylord Nelson Stewardship 2000 Program to \$372 million. Specify that \$35 million in bonding authority would be available annually beginning in 2002-03 through 2009-10. Of that amount, \$23.5 million would be available for the land acquisition subprogram and \$11.5 million would be available for property development and local assistance subprogram. GPR debt service payments would be expected to decline by \$500,000 in 2002-03.
