**Amendment 1- (Super Amendment)**

*JSK* • Delete \$3,000,000 GPR from the Wisconsin Development Fund Grant Program- Department of Commerce.

*JSK*

• Delete 6.75 FTE from the Lt. Governor's Office and consequently adjust the appropriation schedule to reflect savings of \$450,600. Specify that the Lt. Governor's office will be merged with the Governor's office for the purposes of administrative support.


