RE: Budget Amendments- Drafting Language

Steve, here is the language for our major amendment which will be drafted as an amendment to the ARC super simple. There are a couple of items that still need to be fleshed out (we are waiting on information from Fiscal Bureau) and no doubt we will need to make some revisions.

Amendment 1- (Super Amendment)

- PSK* • Delete \$3,000,000 GPR from the Wisconsin Development Fund Grant Program- Department of Commerce.
- JTK* • Delete 6.75 FTE from the Lt. Governor's Office and consequently adjust the appropriation schedule to reflect savings of \$450,600. Specify that the Lt. Governor's office will be merged with the Governor's office for the purposes of administrative support.

RSM/PTD

- Restrictions for Expenditures for Legal and Consulting Fees for Redistricting: No more than \$260,000 may be expended for legal and consulting services per House. (see LRBb1371/1)

RAC

- Delete executive assistant positions in all GPR financed agencies and consequently adjust the appropriation schedule to reflect savings of \$1,134,900. This would include DADCP, DPL, WI Technical College System, DOC, DHFS, DOJ, Military Affairs, DOA, Employment Relations and DOR.

 Take out reference look at 52420

- Delete 1/2 communication officers and legislative liaisons- drafting instructions will be forthcoming.

RAC

- Delete 13.0 FTE from the Department of Administration, State Budget Office and consequently adjust the appropriation schedule to reflect savings of \$923,150.

STK

- Delete 4.0 FTE (1.0 chief information officer, 1.0 deputy secretary, 1.0 executive assistant, 1.0 division administrator) from the Department of Electronic Government Office and consequently adjust the appropriation schedule to reflect savings of \$409,800. Instruct that the Department becomes a division within the Department of Administration.

STK

- Delete \$69, 424 from the Office of the Governor's supplies and services account in order to reduce the amount available for air travel.

RAC

- Voluntary Employee Furlough – Joint Finance motion 273 (see attached). Also, include a provision mandating that furloughs may not be taken for the sole purpose of participating in partisan political activity.

MCS/RMK

- Consolidate Consumer Protection into the Department of Justice: Please refer to Joint Finance DADCO Paper 1110 Motion 202 (see attached)

MES

- Add to the Department of Revenue:
 - o 15.0 (FTE) Office Revenue Positions
 - o 20.0 (FTE) Field Revenue Agents
 - o 10.0 (FTE) Large Case Field Auditors
 - o 10.0 (FTE) District Field Auditors
 - o 20.0 (FTE) Office Auditors

- *Office of Justice Assistance- drafting instructions will be forthcoming*
- New Lisbon Correctional Institution- Pg 45 - #2 Delete Assembly Republican Caucus action regarding New Lisbon. Specify that this change saves the state of Wisconsin \$480,200.
- Highview Geriatric Correctional Facility- Pg 45 #2. Delete Assembly Republican Caucus action regarding Highview. Specify that this change saves the state of Wisconsin \$303,100.
- JK • EGTTRA: Under the category of General Fund Taxes- Internal Revenue Code Update, delete the changes to foreign sales corporations. (LFB ARC Summary page 81). Specify that this change saves the state of Wisconsin \$2,800,000.
- JTK • Require DOA Secretary to mandate state Agencies to ask all outside state contractors they do business with to open up their contracts and renegotiate a 7 percent cut in administrative costs in this biennium. (*Fiscal addition will be forthcoming*)
- RC/MSL • Fully restore DPI funding for public libraries to \$737,500 GPR in 2002-03. Also, delete ARC language that eliminates current law requirements that every public library must be free for the use of inhabitants of the municipality by which it is established and maintained.
- MSL • Restore \$40,000,000 GPR base funding for the UW System.
- DAK • Restore Community Health Center Funding: Please refer to Joint Finance- DHFS Paper 1167 Alt 4. (see attached) as well as LFB pg 94 #9. Reflect additional expense of \$1,575,000.
- JK • Maintain Shared Revenue at 2002 levels for all years.
