1 AN ACT to amend 77.52 (2) (a) 6. of the statutes; relating to: the sales tax
2 imposed on coin-operated, self-service laundry services.

Analysis by the Legislative Reference Bureau

Under current law, laundry services performed by a customer using coin-operated, self-service machines are not subject to the sales tax. This bill imposes the sales tax on such services.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 " SECTION 1. 77.52 (2) (a) 6. of the statutes is amended to read:

4 77.52 (2) (a) 6. ^{233b} Laundry, dry cleaning, pressing, and dyeing services, except
5 when performed on raw materials or goods in process destined for sale, and except
6 when performed on cloth diapers by a diaper service and except when the service is
7 performed by the customer through the use of coin-operated, self-service machines.
