

1 AN ACT to repeal 77.54 (23m) of the statutes; relating to: repealing the sales
2 tax and use tax exemption for motion picture film and tape.

Analysis by the Legislative Reference Bureau

Under current law, motion picture film and tape, and related advertising materials, that are sold, leased, or rented to a motion picture theater or radio or television station are exempt from the sales tax and use tax. This bill repeals the sales tax and use tax exemption for such motion picture film and tape.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 "SECTION ~~1.~~ 77.54 (23m) of the statutes is repealed."

4 ~~SECTION 2. Effective date.~~

5 "(1) ~~this act~~ takes effect on the first day of the 2nd month beginning after
6 publication."
