Analysis by the Legislative Reference Bureau

This bill imposes the sales tax on services performed by a bank, savings bank, savings and loan association, or credit union related to accounts held by such institutions and for which fees are assessed by such institutions.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
