4 25.66 (1) (f) Beginning in fiscal year 2002-03, all moneys deposited by the
5 department of revenue under s. 139.455."

6 ✓ 2. Page 168, line 13: after that line insert:

7 "SECTION 319[✓]d. 139.455 of the statutes is created to read:

8 **139.455 Revenue distribution to the tobacco control fund.** Each fiscal
9 year, beginning in fiscal year 2002-03, the department shall deposit the first
10 \$25,000,000 of the taxes collected under this subchapter into the tobacco control
11 fund."
