2 1. Page 182, line 16: after that line insert:

3 "SECTION 369f. 253.15^x of the statutes is created to read:

4 **253.15 Information relating to adoption of children.** The department
 5 shall prepare and distribute to all school boards that provide instructional programs
 6 in human growth and development under s. 118.019[✓], for inclusion in the ~~curriculum~~
 7 ~~for the program~~, informational materials describing the procedures governing the
 8 adoption of children and listing, by geographical region, all public and private
 9 agencies that provide adoption services."

10 2. Page 358, line 15: after that line insert:

11 ^d
 "(4~~x~~)[≡] PREPARATION AND DISTRIBUTION OF ADOPTION INFORMATION. By the first day
 12 of the 4th month beginning after the effective date of this subsection, the department

1 of health and family services shall prepare and distribute the informational
2 materials specified in section 253.15[✓] of the statutes, as created by this act, as
3 required under that section of the statutes.”.

4 **3.** Page 436, line 23: after that line insert:

5 ^d~~(2)~~ ADOPTION INFORMATION IN CURRICULUM[✓]. The treatment of section 253.15[✓] of
6 the statutes (with respect to the inclusion of the information specified in that section
7 of the statutes in the human growth and development[✓] curriculum of a school board)
8 first applies to curriculum provided in the 2002-03 school year.”.
