15 amount is decreased by \$1,893,000 for fiscal year 2002–03 to decrease funding for the
16 division of international and export services and to decrease the authorized FTE
17 positions for the department by 10.0 GPR positions on July 1, 2002, or on the day
18 after publication, whichever is later, for the division of international and export
19 services.”.

21 “(1z) DIVISION OF INTERNATIONAL AND EXPORT SERVICES. The treatment of section
22 20.143 (1) (a) and (g) of the statutes takes effect on July 1, 2002, or on the day after
23 publication, whichever is later.”.
